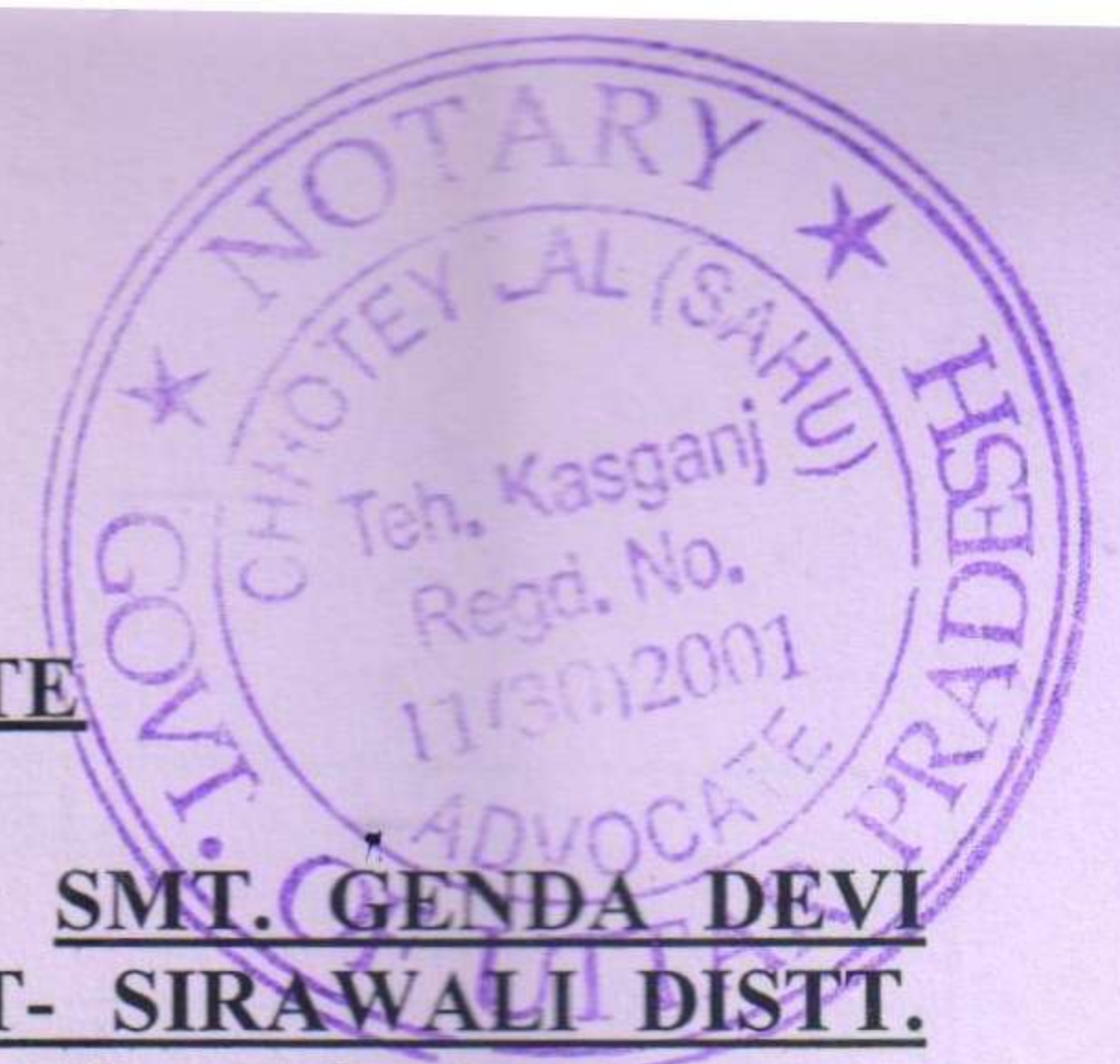


BUILDING COMPLETION CERTIFICATE

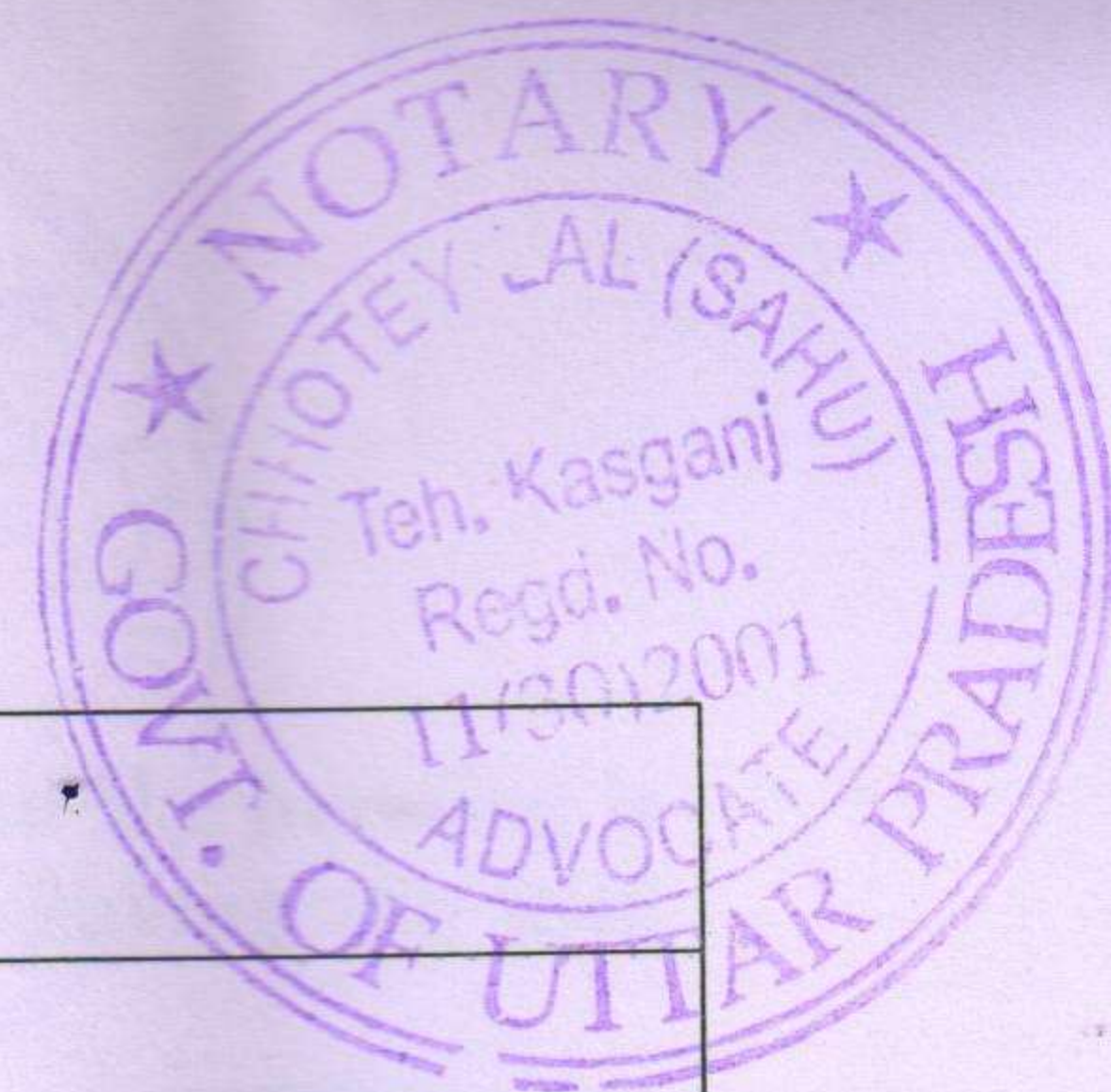

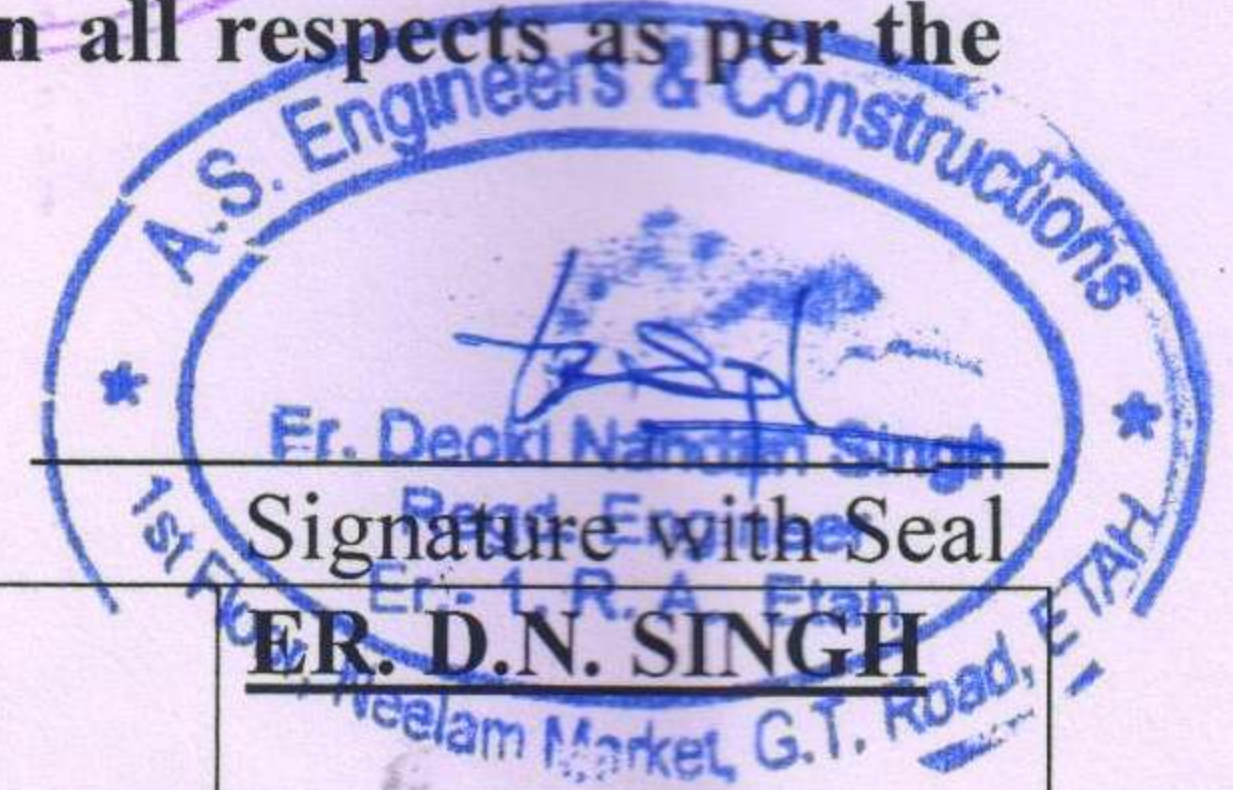
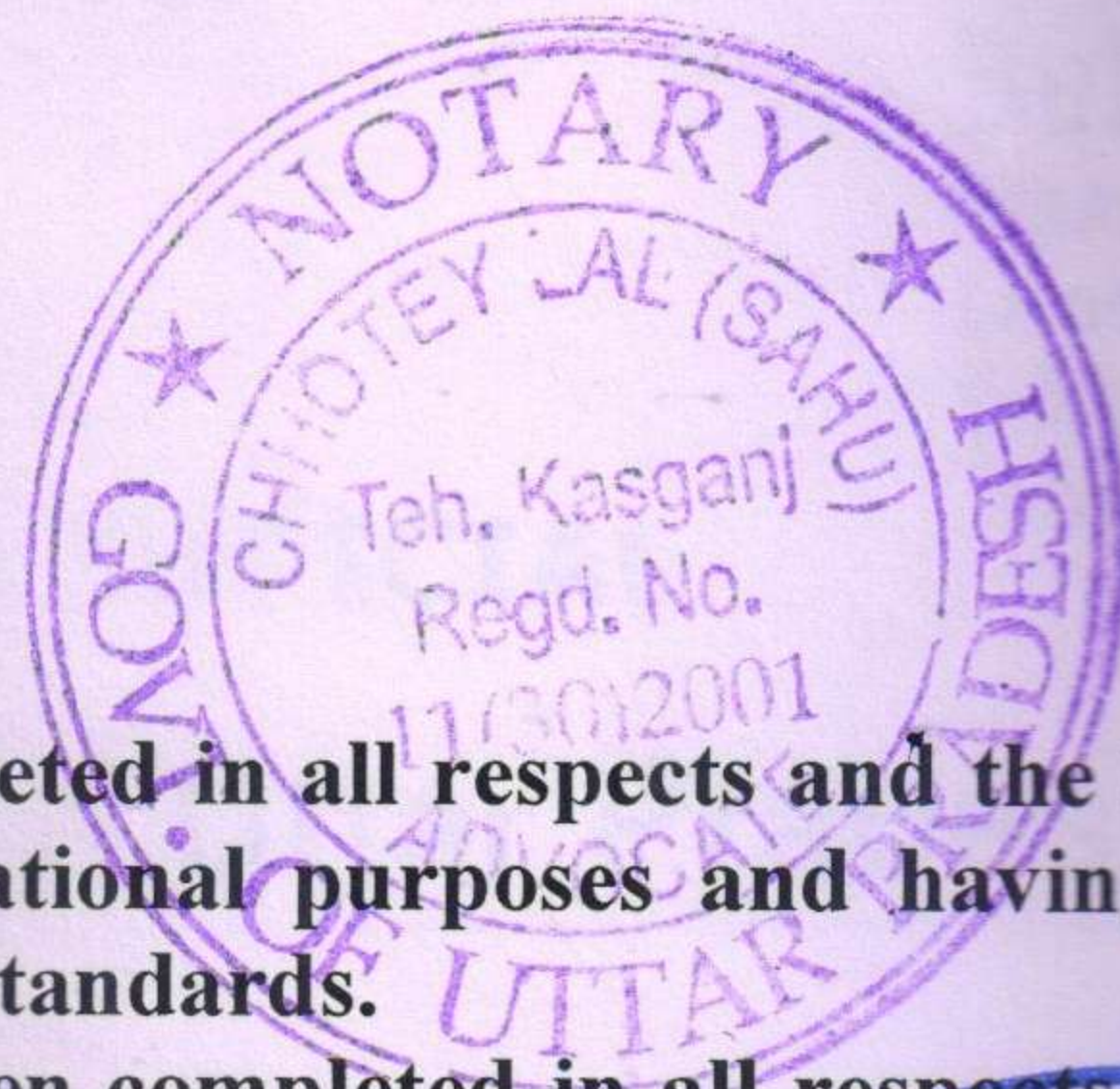
